A RESOLUTION ACCEPTING THE TRANSFER OF CERTAIN PRIVATE WATER MAINS WITHIN THE BRIARCLIFFE LAKES CONDOMINIUM MANOR HOMES TO THE CITY OF WHEATON

WHEREAS, the Board of Directors of the Briarcliffe Lakes Condominium Manor Homes Homeowner's Association has submitted a formal request to transfer the ownership and maintenance of certain private water mains within Briarcliffe Lakes Condominium Manor Homes, a planned unit development in the City of Wheaton, to the City of Wheaton; and

WHEREAS, the Board of Directors has met all the requirements of Section 74-70 of the Wheaton City Code in order to effectuate the transfer of ownership and maintenance of those certain private water mains within the planned unit development to the City.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, DuPage County, Illinois that the City of Wheaton hereby accepts ownership and maintenance of certain private water mains within the Briarcliffe Lakes Condominium Manor Homes Planned Unit Development as described on the Bill of Sale, Deed of Dedication, and Affidavit and Warranty attached hereto and made a part hereof as Exhibit A.

BE IT FURTHER RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois, that the plat of easement grant for water main to the City of Wheaton, prepared by Bruce Smolinski, an Illinois professional land surveyor, dated August 7th, 2023, is hereby approved, and the Mayor is hereby authorized to sign, and the City Clerk is directed to attest to, the plat of easement grant incorporated herein as Exhibit B.

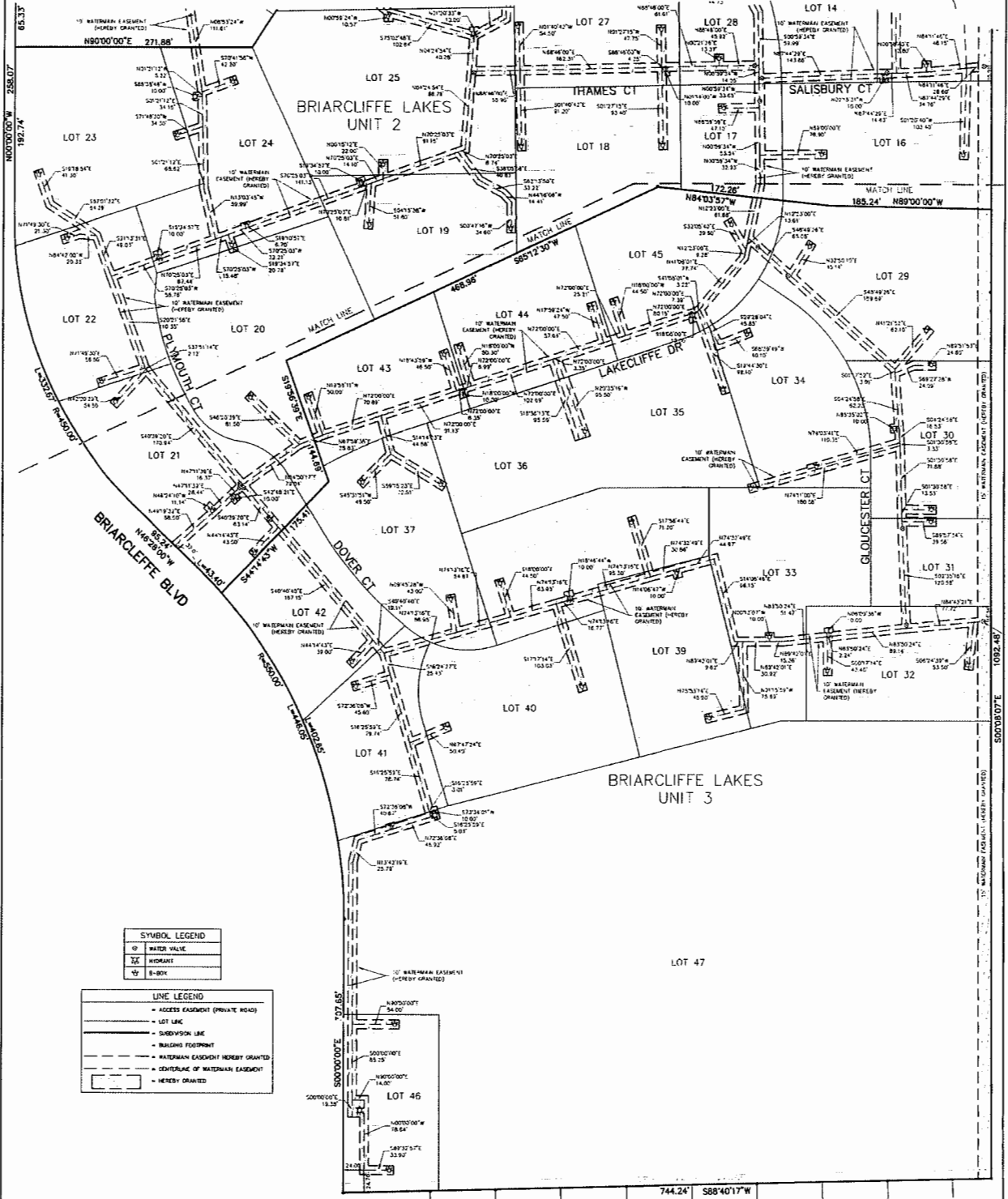
