

**RESOLUTION R-2024-50**

**A RESOLUTION AUTHORIZING THE EXECUTION OF CHANGE ORDER #1 TO AGREEMENT NO. 459 WITH  
R. W. DUNTEMAN COMPANY FOR ADDITIONAL SERVICES FOR THE 2024 ROAD, SEWER, AND WATER  
REHABILITATION PROGRAM FOR A TOTAL AMOUNT NOT TO EXCEED \$48,136.34**

**WHEREAS**, the City of Wheaton, Illinois, ("City") is an Illinois Home Rule Municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and as such the City may exercise any power and perform any function pertaining to its government and affairs; and

**WHEREAS**, on April 15, 2024, the City Council approved Resolution No. R-2024-36 authorizing the City to enter into Agreement No. 459 with R. W. Duntzman Company for the 2024 Road, Sewer, and Water Rehabilitation Program in the amount of \$3,887,993.05; and

**WHEREAS**, during construction, the City received notification from Milton Township about the commencement of their road program. Consequently, the City has opted to extend Plamondon Road by adding two additional sections south of Warrenville Road within the City's right-of-way, ensuring that the City's segment of Plamondon Road connects seamlessly with Milton Township's section; and

**WHEREAS**, staff requested a cost estimate from R. W. Duntzman Company to complete the additional work; and

**WHEREAS**, R. W. Duntzman Company provided the City with a cost estimate in the amount of \$48,136.34 to perform the additional work; and

**WHEREAS**, staff evaluated the cost estimate and deemed it to be reasonable and consistent with unit costs submitted at the time of bid; and

**WHEREAS**, Change Order #1 will increase the amount of Agreement No. 459 by \$48,136.34, bringing the total agreement amount to \$3,936,129.39; and

**WHEREAS**, reserves are available in the Motor Fuel Tax Fund to accommodate the additional cost of \$48,136.34 for added services for the 2024 Road, Sewer, and Water Rehabilitation Program; and

**WHEREAS**, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into Change Order #1 to Agreement No. 459 with R. W. Duntzman Company located at 600 S. Lombard Road, Addison, Illinois 60101 for Additional Work for the 2024 Road, Sewer, and Water Rehabilitation Program for a total amount not to exceed \$48,136.34.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Change Order #1 to Agreement No. 459 with R. W. Duntzman Company for Additional Work for the 2024 Road, Sewer, and Water Rehabilitation Program; and that a copy of that certain City of Wheaton Change Order #1 to Agreement No. 459 is on file in the City Clerk's Office and is incorporated herein as if fully set forth as Exhibit A.
