

**RESOLUTION R-2024-53**

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 475 FOR A MICROSOFT OFFICE 365 AND AZURE SUBSCRIPTION RENEWAL THROUGH THE STATE OF ILLINOIS JOINT PURCHASE MASTER CONTRACT WITH DELL MARKETING LP FOR A THREE-YEAR TERM AND A TOTAL AMOUNT NOT TO EXCEED \$341,297.25**

**WHEREAS**, the City of Wheaton, Illinois, ("City") is an Illinois home rule municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and as such the City may exercise any power and perform any function pertaining to its government and affairs; and

**WHEREAS**, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, *et seq.*), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase supplies; and

**WHEREAS**, the State of Illinois has publicly and competitively bid for a Microsoft Licensing Solutions Provider (LSP), and Illinois awarded Contract #CMT1176800 to Dell Marketing LP, the lowest, responsive and responsible bidder, for the provision of Microsoft products, support, and services and has made the contract available to other public entities; and

**WHEREAS**, a Microsoft Office 365 and Azure Subscription Renewal is offered under State of Illinois Contract #CMT1176800 for three-year term for an annual price of \$113,765.75 (\$341,297.25 three-year total); and

**WHEREAS**, the City budgeted funds in the CY2024 General Fund - Information Technology account in the amount of \$114,315, resulting in a savings of \$549.25 for year one; and

**WHEREAS**, both parties agree to the terms and conditions set forth in State of Illinois joint purchase master contract #CMT1176800 and City Agreement No. 475 for Microsoft Office 365 and Azure Subscription Renewal; and

**WHEREAS**, the corporate authorities of the City of Wheaton find it reasonable and appropriate to enter into an agreement with Dell Marketing LP located at One Dell Way RR8-06, Round Rock, Texas 78582 through the State of Illinois joint purchase master contract #CMT1176800 for the purchase of a Microsoft Office 365 and Azure Subscription Renewal for a total amount not to exceed \$341,297.25.

**NOW THEREFORE, BE IT RESOLVED** by the Mayor and the City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 475 with Dell Marketing LP for a Microsoft Office 365 and Azure Subscription Renewal, through the State of Illinois joint purchase master contract #CMT1176800; and that a copy of that certain City of Wheaton Agreement No. 475 is on file with the City Clerk's office and is incorporated herein as if fully set forth as Exhibit A.
