

**RESOLUTION R-2024-54**

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 469 FOR BULK ROCK SALT THROUGH THE DUPAGE COUNTY JOINT PURCHASING SOLICITATION WITH MORTON SALT, INC. TO BE PURCHASED ON AN AS NEEDED BASIS AT THE PRICE PER TON SET FORTH IN MORTON SALT'S COST PROPOSAL**

**WHEREAS**, the City of Wheaton, Illinois, ("City") is an Illinois home rule municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and as such the City may exercise any power and perform any function pertaining to its government and affairs; and

**WHEREAS**, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, *et seq.*), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase supplies; and

**WHEREAS**, the City participated in a joint purchasing solicitation (Bid #24-OSALT-01-MS) led by DuPage County, which included a total of 37 surrounding communities for Bulk Rock Salt; and

**WHEREAS**, DuPage County solicited bids in a public bidding process and bids were publicly opened and read on May 14, 2024, at 2:00 PM and Morton Salt, Inc. was determined to be the lowest, responsive, responsible bidder for bulk rock salt at a price of \$73.90/ton delivered for up to 130% of the estimated 2,000 tons, and \$93.90/ton delivered for 130% up to 150% of the projected usage; and

**WHEREAS**, the City budgeted funds in the General Fund-Road Materials account in the amount of \$247,670 for Bulk Rock Salt; and

**WHEREAS**, both parties agree to the terms and conditions set forth in the Invitation to Bid package and the agreement for Bulk Rock Salt; and

**WHEREAS**, the corporate authorities of the City of Wheaton find it reasonable and appropriate to enter into an agreement with Morton Salt, Inc. located at 444 West Lake Street, Suite 2900, Chicago, Illinois 60606 through the DuPage County joint purchasing solicitation Bid #24-OSALT-01-MS for the purchase of Bulk Rock Salt on an as needed basis at the price per ton set forth in Morton Salt's cost proposal.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 469 with Morton Salt, Inc. for the purchase of Bulk Rock Salt on an as needed basis at the price per ton set forth in Morton Salt's cost proposal; and that a copy of that certain City of Wheaton Agreement No. 469 is on file with the City Clerk's office and is incorporated herein as if fully set forth as Exhibit A.
