

**RESOLUTION R-2024-59**

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 478 WITH  
SUPERIOR ROAD STRIPING INC. FOR THERMOPLASTIC ROAD STRIPING SERVICES THROUGH THE JOINT  
PURCHASING PROGRAM WITH DUPAGE COUNTY FOR A TOTAL AMOUNT NOT TO EXCEED \$90,000  
AND A 10% CONTINGENCY**

**WHEREAS**, the City of Wheaton, Illinois, ("City") is an Illinois home rule municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and as such the City may exercise any power and perform any function pertaining to its government and affairs; and

**WHEREAS**, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, *et seq.*), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase supplies; and

**WHEREAS**, DuPage County ("County") has publicly and competitively bid for Thermoplastic Road Striping Services; and

**WHEREAS**, the County awarded contract #24-PVMKG-12-GM to Superior Road Striping Inc., the lowest, responsive, responsible bidder and has made the contract available to other public entities; and

**WHEREAS**, it is determined that the contract with Superior Road Striping Inc. meets the City's needs; and


**WHEREAS**, the City budgeted funds in the General Fund for an amount of \$100,000 for Thermoplastic Road Striping Services; and

**WHEREAS**, the corporate authorities of the City of Wheaton find it reasonable and appropriate to enter into an agreement with Superior Road Striping Inc. located at 1980 N. Hawthorne Ave., Melrose Park, Illinois 60160 for Thermoplastic Road Striping Services through DuPage County contract #24-PVMKG-12-GM for a total amount not to exceed \$90,000 and a 10% contingency.

**NOW THEREFORE, BE IT RESOLVED** by the Mayor and the City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 478 with Superior Road Striping Inc. for Thermoplastic Road Striping Services; and that a copy of that certain City of Wheaton Agreement No. 478 is on file with the City Clerk's office and is incorporated herein as if fully set forth as Exhibit A.
