

RESOLUTION R-2024-62

A RESOLUTION AUTHORIZING THE PURCHASE OF ONE (1) REPLACEMENT AERIAL BUCKET TRUCK FROM ALTEC INDUSTRIES, INC. THROUGH THE SOURCEWELL PURCHASING COOPERATIVE FOR A TOTAL AMOUNT NOT TO EXCEED \$122,845

WHEREAS, the City of Wheaton, Illinois, ("City") is an Illinois home rule municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and as such the City may exercise any power and perform any function pertaining to its government and affairs (the "Home Rule Powers"); and

WHEREAS, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, *et seq.*), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase supplies; and

WHEREAS, Sourcewell is a state of Minnesota local government unit and service cooperative purchasing program created by the Minnesota legislature under the laws of the State of Minnesota (Minnesota Statutes Section 123A.21) and is authorized to contract with eligible entities to perform governmental functions including the purchase of goods and services; and

WHEREAS, the City participates in the Sourcewell cooperative purchasing program, which establishes contracts for a variety of products and services through public and competitive solicitations, and permits member governments to purchase products and services through those contracts; and

WHEREAS, Sourcewell contract #110421-ALT has been publicly and competitively bid for Public Utility Equipment with Related Accessories and Supplies; and

WHEREAS, Sourcewell has identified Altec Industries, Inc. located in Indianapolis, Indiana as the low responsible bidder for Sourcewell cooperative contract #110421-ALT; and

WHEREAS, the City budgeted funds in the Vehicles account of the Fleet Services Fund in the amount of \$133,901; and

WHEREAS, the corporate authorities of the City of Wheaton have determined that it is in the best interest of the City to procure one (1) Replacement Aerial Bucket Truck from Altec Industries, Inc. located at 5201 W. 84th Street, Indianapolis, IN 46268 in accordance with Sourcewell cooperative contract #110421-ALT for a total amount not to exceed \$122,845.

NOW THEREFORE, BE IT RESOLVED by the Mayor and the City Council of the City of Wheaton, Illinois, that:


Section 1. The foregoing recitals are incorporated into and made a part of this Resolution as findings of the Mayor and the City Council.

Section 2. The City's Purchase Order #2025079 for the purchase of one (1) Replacement Aerial Bucket Truck from Altec Industries, Inc. for a total amount not to exceed \$122,845, is hereby authorized (the "Purchase"). A copy of the City's Purchase Order #2025079 is on file with the City Clerk's office, and is incorporated herein as if fully set forth as Exhibit A.

Section 3. City staff is authorized and directed to undertake any and all other tasks necessary, or in furtherance of, completion of the Purchase transaction.
