City Manager Michael Dzugan Retiring after 33 Years of Service



City Manager Michael Dzugan announced that he will be retiring from the position of City Manager, following 33 years of service to the Wheaton community, and over 42 years serving local government. Before being appointed City Manager in 2016, Dzugan served as the City's Assistant City Manager for 25 years. He served as Assistant City Manager in Crystal Lake prior to joining the City of Wheaton.

The City has begun soliciting applicants for the next Wheaton City Manager. The successful candidate will be selected by the Wheaton City Council, with input from City staff. Dzugan will step down from his current position upon the hiring of the next City Manager and will assist the City with the transition process. His anticipated retirement from the

City will be mid-year 2025.

Under his tenure, Dzugan led the City through unprecedented times, finding ways to deliver uninterrupted City services through the Covid-19 pandemic while prioritizing community safety and supporting the local business community.

The City of Wheaton is among 19 communities in Illinois to receive Standard & Poor's top "AAA" financial rating, reflecting the City's strong economy, financial policies and budgetary performance.

Among the landmark projects during Dzugan's leadership, the City completed a \$35 million revitalization of the downtown through the Downtown Streetscape Project. As a result of this investment in the downtown, Wheaton has welcomed an influx of new restaurants, retail stores, businesses and new housing projects.

The City of Wheaton thanks City Manager Dzugan for 33 years of outstanding service to the community, leading with integrity and dedication to ensure Wheaton is a safe and vibrant community that provides high-quality services to its residents. City of Wheaton Leaf Collection Reminders

This fall, the City of Wheaton reminds you of the ways you can properly dispose of leaves. Place leaves in containers 35 gallons in size or smaller, or in biodegradable bags. Containers or bags must weigh less than 50 pounds when filled. Each container or bag requires an LRS yard waste/organics/excess garbage sticker, available at City Hall and at many local grocery and hardware stores for \$3.49 each.

When you're cleaning up leaves, please be careful not to blow or rake them into the streets. Doing so can prevent storm sewers from functioning properly and can lead to flooding. If your house

is located near a storm sewer catch basin, please help keep it clear by sweeping away leaves and debris from the sewer grate. Also, please note that burning leaves is not allowed. LRS collects yard waste, food scraps and organic materials on your garbage day through the second full week of December. An environmentally friendly alternative to bagging leaves is to mulch them into your lawn and/or garden beds. Using a lawnmower with a mulching function can break down leaves into small pieces, allowing them to be either collected and spread into garden beds or finely shredded into lawns to break down.

Halloween Safety Tips and Trick-or-Treating Hours



As children throughout our community start getting their costumes ready for Halloween, the City reminds you that the trick-or-treating hours in Wheaton will be 3:30 p.m. to 7:30 p.m. on Thursday, Oct. 31. Drivers should use extra caution on Halloween to ensure the safety of trick-or-treaters.

To promote safety and protect children, the Wheaton Police Department offers the following tips:

- Trick-or-treat on one side of the street at a time. Refrain from crossing the street in the middle of the block or between parked cars.
- Trick-or-treat while it is light outside. If you must be out after dark, wear light-colored clothing, put reflective tape on your costume and treat bag, and carry a flashlight.
- Dress children in non-flammable costumes that fit properly. Avoid wearing facial masks, which obstruct vision. Use face paint and makeup instead.
- Trick-or-treat with friends and stay in a group.
- An adult or responsible teen should accompany younger children at all times.
- Advise children not to enter any residence or

vehicle for the promise of anything.

- Plan your trick-or-treat routes ahead of time, staying in your immediate neighborhood. Parents, take notice of whom your children are with and the routes they are taking.
- Always walk on the sidewalk while trick-or-treating. If there is no sidewalk on the street, keep to the left, next to the curb, and walk single file facing (against) traffic.
- Be courteous and respectful of others' property.
- Homeowners should leave outside porch lights on. If you do not want trick-or-treaters to visit your home, turn off your exterior lights, and/or place a ["no trick-or-treating here" sign](#) on your door.

[Downtown Wheaton Trick-or-Treating](#), hosted by the Downtown Wheaton Association, will take place on Saturday, Oct. 26 from 10 a.m.-1 p.m. During this event, businesses throughout the downtown welcome children to get a head start on trick-or-treating by visiting downtown businesses.

Please note that the sidewalk at the northwest corner of Main and Front streets is temporarily closed due to building construction happening near this corner. For everyone's safety, please only cross the street using marked crosswalks, and remind children to do the same. To get around this closure, pedestrians can use the crosswalk to the south side of Front Street and the crosswalk to the east side of Main Street. Thank you for your assistance in helping keep all participants safe during this popular event.

Capital Improvement Projects Update

A key element of Wheaton's strategic plan is enhanced infrastructure. Roughly 25% of our annual budget or approximately \$30 million is dedicated each year to various infrastructure projects. These projects include maintaining our existing infrastructure and building out new infrastructure. The following are highlights of projects from this year and important improvements slated for 2025.

The City's Water Division has made significant strides in the Lead Service Line Replacement Program, a multi-year initiative replacing lead service lines with modern copper ones, ensuring access to safe, high-quality drinking water for our community. This year, the program is on track to replace 120 service lines, on both City and private property,

at no additional cost to the property owners. In 2025, the City is projected to invest \$700,000 in this program and aims to replace more than 130 service lines on both private and City property. In addition, the City projects investing \$1.5 million toward replacing water mains on James Court, Golf Lane, Golf Circle, and Frazier Court in 2025.

Road improvements have been a focal point of the City's 2024 efforts, with several miles of roads already upgraded as part of our annual Road Improvement Program. So far in 2024, the City has improved 7.7 miles of roads and is expected to complete a total of 8.8 miles by the end of the calendar year. In addition, crews are continuing to work towards the reconstruction of Gary Avenue between Harrison Avenue and Jewell Road which will add a traffic light at the intersection of Gary and Prairie to improve traffic flow. In 2025, the City is projected to invest \$6.2 million in road-related projects, which include the Hunters Glen Subdivision resurfacing, Gary Avenue reconstruction, Gables Boulevard reconstruction, and

concrete street resurfacing. Additionally, crews plan to perform important maintenance on the Manchester Road/ Wesley Street Bridge and the Butterfield Road Pedestrian Bridge.

The City has also made notable progress this year in upgrading the sanitary sewer system. Crews replaced sanitary sewer lines along Kingston Street and College Avenue and coordinated this work with water main replacements in the same area. Public Works crews will have also replaced 10 sanitary sewer structures by the end of 2024. Other notable projects included High Density Polyethylene lining replacements of existing sewer lines, manhole rehabilitations, and flow metering.

Major sanitary sewer projects planned for 2025 include the rehabilitations of the Blacksmith and Albright Lift Stations, sewer main rehabilitation, manhole rehabilitation, and the Sanitary Sewer Reimbursement Program. The Basin 3 & 4 Discharge Replacement Project is another sanitary main project slated for 2025. This major project will replace large sanitary mains near Main Street

and Roosevelt Road which will improve the sanitary flow restrictions in the area.

In the ongoing effort to reduce overland flooding, the City is projected to invest \$2 million in 2025 toward various flood improvement projects. As part of the Storm Sewer Replacement Program, Public Works crews plan to replace over 50 storm structures. Crews also plan to perform rehabilitation of the Lake A Pump Station, which plays a key role in minimizing flooding on Wheaton's east side. In 2024, Public Works crews have replaced over 45 storm sewer structures and installed over 1,311 feet of new storm sewer. The Cadillac & Wakeman Flood Control Project, completed in 2024, installed new stormwater infrastructure from Parkway Drive to Cole Avenue. This project will help decrease overland flooding into homes in this area.

Through the New Sidewalk Program, a multi-year program to add sidewalks on at least one side of every street to increase safety for pedestrians and improve walkability, crews are on track to

complete 2.5 miles of sidewalks and plan to install an additional 2.5 miles of sidewalks in 2025. As a part of the Roosevelt Road Sidewalk Program, 4,600 feet of new sidewalks have been installed this year on the south

side of Roosevelt Road, creating full sidewalk connectivity from County Farm Road to Lorraine Road. This project is another example of the City's goal to make our community more pedestrian-friendly and increase safety.

Additionally, significant

updates to the Wheaton Public Library are slated for 2025 with the facility's roof replacement and West Side Plaza renovations.

Investing in infrastructure is essential for the City to maintain a high quality of life for residents, support public health

and safety, and promote economic growth and development both now and for future generations. We will continue to work to ensure that the City's infrastructure and capital projects meet the community's service level needs and expectations.

City to Begin Accepting Candidate Petitions for 2025 Municipal Election

The Office of the City Clerk will accept candidate petitions for nomination for the 2025 municipal election between 8 a.m. and 5 p.m. Monday through Friday, Oct. 21-25, and Monday, Oct. 28, at City Hall, 303 W. Wesley St. If necessary, the Consolidated Primary Election will be held on Feb. 25, 2025, and the Consolidated General Election will be held on April 1, 2025 for the offices of:

- Councilmember, North District (1 position);
- Councilmember, East District (1 position);
- Councilmember, West District (1 position); and
- Councilmember, South District (1 position).

City to Continue Garbage, Recycling and Yard Waste Services with LRS; New Agreement to Begin Oct. 1



The Wheaton City Council approved a 5-year agreement with LRS for garbage, recycling and yard waste service for residents, which started Oct. 1. The new agreement allows residents to continue paying based on the amount of garbage, recycling or yard waste they generate, and service will continue as it does today, with adjusted rates for each year of the contract.

Under the new agreement, the price per pickup for the first year will increase between \$0.39 and \$0.65 per pickup for garbage and between \$0.25 and \$0.41 per pickup for recycling service, based on cart sizes, with a 3.7% increase in subsequent years of the contract. The cost of yard waste/extra garbage stickers will be \$3.49, with a 3.7%

increase per year. The average household cost for solid waste and recycling collection in Wheaton beginning in October is anticipated to be \$15.21 per month.

You will continue to use your current garbage and recycling carts, which use RFID (Radio Frequency Identification) chips that LRS trucks scan each time they are emptied and charge you only when you set your carts at the curb. This “pay as you throw” model ensures collection costs are distributed fairly, in proportion to the amount of waste each user generates. This type of program also helps encourage residents to decrease waste and increase recycling, promoting environmental sustainability.

Installing an Electric Vehicle (EV) Charger in Your Home

If you're among the growing number of people who are considering purchasing an electric vehicle (EV), you may also be considering installing an EV home charging station. An EV charger is a device that provides the electrical power needed to recharge electric cars. These chargers come in various types, primarily differentiated by their connector types and charging speeds.

Before installation, you should first have a licensed electrician perform an inspection concerning the following:

- Assessment of the proposed electrical load to ensure that the existing electrical service is large enough to handle the additional power draw.
 - Verifying that your electrical service panel has room for the new circuit and can safely accept any new circuits.
- Checking these areas of concern is critical for the safe operation of your home's electrical system. Keep in mind that most manufacturer warranties for both the EV charger and the vehicle will require that a licensed electrician perform the installation.
- A permit is required by the City of Wheaton to add an EV charger to your home. For more information, visit [the City's Residential/Commercial Projects & Permits page](#) and select “Electric Car Charger” under the dropdown menu or call the Building Department at 630-260-2050.

Water Rate Changes Approved to Support Necessary Infrastructure Projects

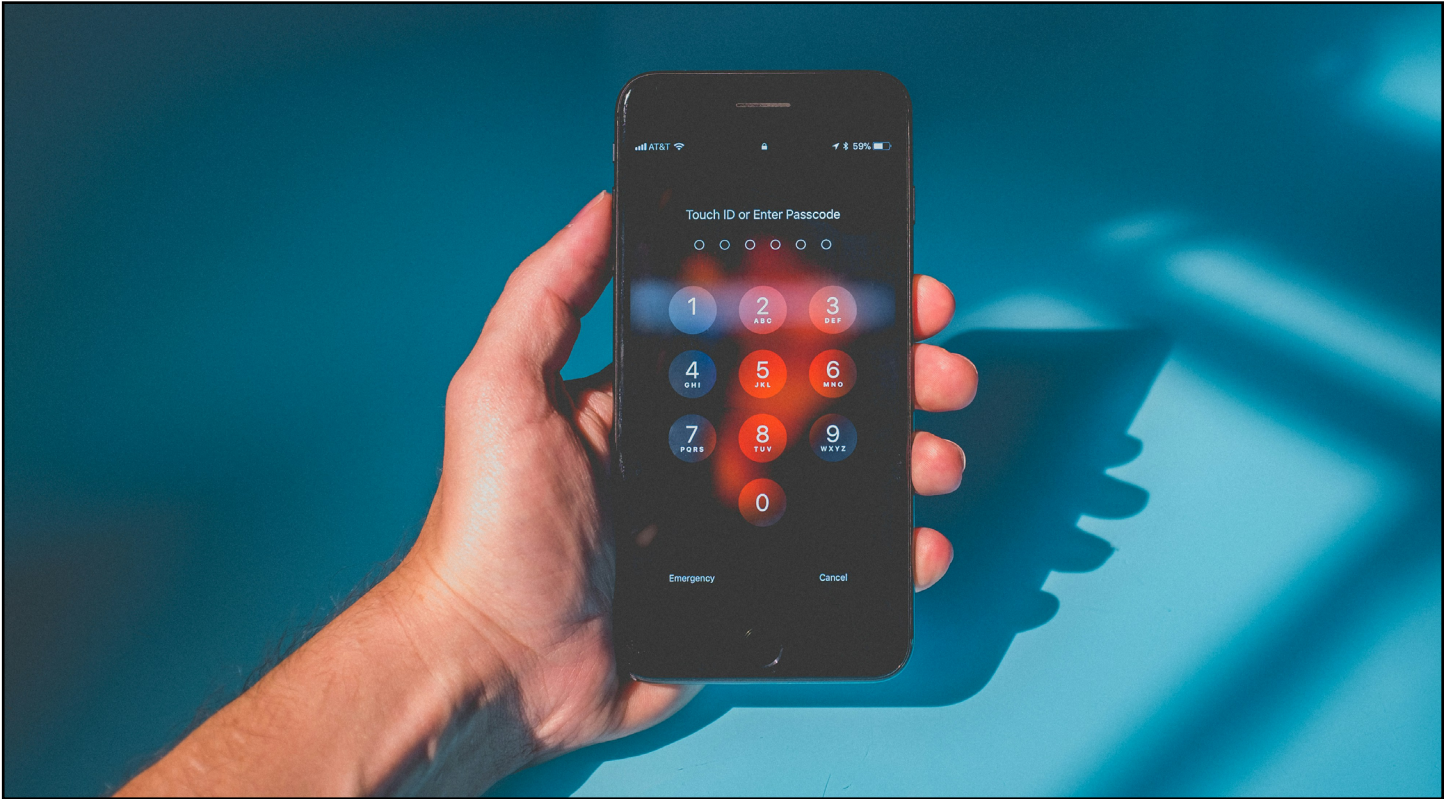


The Wheaton City Council has approved changes to the City's water rates to address aging water infrastructure, significant increases in the amount the City pays to purchase water, and rising expenses to operate the City's water system.

These changes implement the recommendations of the [Wheaton Water Rate Study](#), which includes the first adjustments to the City's water rates in 9 years, and annual adjustments to the rate that directly reflect how much the City pays to purchase water from the DuPage Water Commission. These changes will begin with water customers' January 2025 utility bill.

The impact on a customer's monthly water bill will vary based on their water meter size and consumption levels, however the average water customer is expected to see a monthly increase of approximately \$6.82 in 2025. More information is available on [the City's website](#).
