

RESOLUTION R-2024-88

**A RESOLUTION AUTHORIZING THE EXECUTION OF CHANGE ORDER #2 TO AGREEMENT NO. 459 WITH
R.W. DUNTEMAN COMPANY FOR ADDITIONAL SERVICES FOR THE 2024 ROAD, SEWER, AND WATER
REHABILITATION PROGRAM FOR A TOTAL AMOUNT NOT TO EXCEED \$211,861.48**

WHEREAS, the City of Wheaton, Illinois, ("City") is an Illinois Home Rule Municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and as such the City may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, on April 15, 2024, the City Council approved Resolution No. R-2024-36 authorizing the City to enter into Agreement No. 459 with R.W. Dunteman Company for the 2024 Road, Sewer, and Water Rehabilitation Program in the amount of \$3,887,993.05; and

WHEREAS, on June 3, 2024, the City Council approved Resolution No. R-2024-50 for Change Order #1 which increased the total of Agreement No. 459 by \$48,136.34, bringing the total agreement amount to \$3,936,129.39; and

WHEREAS, during construction unexpected field conditions were discovered that required corrective action to avoid costly delays therefore staff requested a cost estimate from R.W. Dunteman Company to complete the additional work; and

WHEREAS, R.W. Dunteman Company provided the City with a cost estimate in the amount of \$211,861.48 to perform the additional work; and

WHEREAS, staff evaluated the cost estimate and deemed it to be reasonable and consistent with unit costs submitted at the time of bid and instructed R.W. Dunteman Company to perform the additional work; and

WHEREAS, Change Order #2 will increase the amount of Agreement No. 459 by \$211,861.48, bringing the total agreement amount to \$4,147,990.87; and

WHEREAS, there are reserves available in the Motor Fuel Tax Fund to accommodate the additional cost of \$211,861.48 for added services for the 2024 Road, Sewer, and Water Rehabilitation Program; and

WHEREAS, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into Change Order #2 to Agreement No. 459 with R.W. Dunteman Company located at 600 S. Lombard Road, Addison, Illinois 60101 for Additional Work for the 2024 Road, Sewer, and Water Rehabilitation Program for a total amount not to exceed \$211,861.48.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Change Order #2 to Agreement No. 459 with R.W. Dunteman Company for Additional Work for the 2024 Road, Sewer, and Water Rehabilitation Program; and that a copy of that certain City of Wheaton Change Order #2 to Agreement No. 459 is on file in the City Clerk's Office and is incorporated herein as if fully set forth as Exhibit A.
