

**RESOLUTION R-2025-03**

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 513 WITH  
VULCAN CONSTRUCTION MATERIALS, LLC FOR AGGREGATE MATERIALS TO BE PURCHASED ON AN AS  
NEEDED BASIS AT THE PRICE PER TON SET FORTH IN VULCAN CONSTRUCTION MATERIALS, LLC'S  
COST PROPOSAL**

**WHEREAS**, the City of Wheaton, Illinois, ("City") is an Illinois home rule municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and as such the City may exercise any power and perform any function pertaining to its government and affairs; and

**WHEREAS**, the City solicited an Invitation to Bid package (ITB Number 24-235) for the purchase of Aggregate Materials and Vulcan Construction Materials, LLC was determined to be the lowest, responsive, responsible bidder with a bid amount of \$57,753.75; and

**WHEREAS**, the City budgeted funds for CY2025 in multiple accounts (General, Water, Sanitary Sewer, and Storm Sewer) for a total amount of \$64,300.00 for Aggregate Materials; and

**WHEREAS**, the budgeted amount for aggregate materials and reserves can only be estimated based on a myriad of variables that can affect the City's needs which in turn requires expenditure flexibility to accommodate those variables, in meeting the essential need of the Public Works Department; and

**WHEREAS**, both parties agree to the terms and conditions, and pricing set forth in the ITB and the agreement contained in the City's bid package for Aggregate Materials; and

**WHEREAS**, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Vulcan Construction Materials, LLC located at 1000 E. Warrenville Rd, Suite 100, Naperville, Illinois 60563 for Aggregate Materials for a total amount not to exceed \$64,300.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 513 with Vulcan Construction Materials, LLC for Aggregate Materials; a copy of that Agreement being on file with the City Clerk's office, and which is incorporated herein as if fully set forth as Exhibit A.
