

**RESOLUTION R-2025-10**

**A RESOLUTION RATIFYING THE CITY MANAGER'S CHANGE ORDER AND AUTHORIZING THE EXECUTION OF CHANGE ORDER #2 TO AGREEMENT NO. 456 WITH BRANDT EXCAVATING, INC. FOR THE 2024 LEAD SERVICE LINE REPLACEMENT PROGRAM FOR A TOTAL AMOUNT NOT TO EXCEED \$13,105.80 AND A TOTAL AWARD OF \$480,326.80**

**WHEREAS**, the City of Wheaton, Illinois, ("City") is an Illinois Home Rule Municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and as such the City may exercise any power and perform any function pertaining to its government and affairs; and

**WHEREAS**, on April 1, 2024, the City Council approved Resolution No. R-2024-29 authorizing the City to enter into Agreement No. 456 with Brandt Excavating, Inc. for the 2024 Lead Service Line Replacement Program in the amount of \$433,096.00 and a 10% contingency; and

**WHEREAS**, on October 3, 2024, the City Manager approved Change Order #1 in the amount of \$34,125.00, which was within the approved contingency amount; and

**WHEREAS**, during construction, staff identified additional lead service line replacements and additional landscaping costs which was not included in the initial plan, and a decision to move forward with the additional work was made by the City Manager; and

**WHEREAS**, the Procurement Policy authorizes the City Manager to approve certain change orders subject to ratification by the City Council; and

**WHEREAS**, the contract for construction services was executed with an original amount of \$433,096.00 and a 10% contingency; and

**WHEREAS**, the corporate authorities of the City find it reasonable and appropriate to approve Change Order #2 to Agreement No. 456 with Brandt Excavating, Inc. located at 385 E Hoover St., Morris, Illinois 60450 for the 2024 Lead Service Line Replacement Program in the amount of \$13,105.80 and a total award of \$480,326.80.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Wheaton, Illinois, that:

The approval by the City Manager of Change Order #2 is hereby approved, ratified and confirmed; and the Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Change Order #2 to Agreement No. 456 with Brandt Excavating, Inc. for Additional Work for the 2024 Lead Service Line Replacement Program; and that a copy of Change Order #2 to Agreement No. 456 is on file in the City Clerk's Office and is incorporated herein as if fully set forth as Exhibit A.
