

RESOLUTION R-2025-12

**A RESOLUTION AUTHORIZING THE PURCHASE OF FIREFIGHTING PERSONAL PROTECTIVE EQUIPMENT
FROM DINGES FIRE COMPANY THROUGH THE SOURCEWELL PURCHASING COOPERATIVE FOR A TOTAL
AMOUNT NOT TO EXCEED \$40,950**

WHEREAS, the City of Wheaton, Illinois, ("City") is an Illinois home rule municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and as such the City may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, *et seq.*), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase supplies; and

WHEREAS, Sourcewell is a state of Minnesota local government unit and service cooperative purchasing program created by the Minnesota legislature under the laws of the State of Minnesota (Minnesota Statutes Section 123A.21) and is authorized to contract with eligible entities to perform governmental functions including the purchase of goods and services; and

WHEREAS, the City participates in the Sourcewell cooperative purchasing program, which establishes contracts for a variety of products and services through public and competitive solicitations, and permits member governments to purchase products and services through those contracts; and

WHEREAS, Sourcewell contract #010424-LIO has been publicly and competitively bid for Firefighting Personal Protective Equipment; and

WHEREAS, Sourcewell has identified Dinges Fire Company located in Amboy, Illinois, as the low responsible bidder for Sourcewell contract #010424-LIO; and

WHEREAS, a total of \$70,500 is budgeted in the Firefighting/Investigation—Uniform Allowance account for firefighting personal protective gear and other uniform purchases; and

WHEREAS, the corporate authorities of the City of Wheaton have determined that it is in the best interest of the City to procure Firefighting Personal Protective Equipment from Dinges Fire Company located at 243 E. Main Street, Amboy, Illinois, 61310 in accordance with Sourcewell contract #010424-LIO for a total amount not to exceed \$40,950.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and the City Council of the City of Wheaton, Illinois, that:

The City's Purchase Order #2026027 for the purchase of Firefighting Personal Protective Equipment from Dinges Fire Company for a total amount not to exceed \$40,950, is hereby authorized (the "Purchase"). A copy of the City's Purchase Order #2026027 is on file with the City Clerk's office, and is incorporated herein as if fully set forth as Exhibit A.
