

## **RESOLUTION R-2025-22**

### **A RESOLUTION AUTHORIZING THE RENTAL OF TWO (2) 10-TON DUMP TRUCKS FOR THE THOMAS ROAD DRAINAGE IMPROVEMENT PROJECT FROM SUNBELT RENTALS, INC. THROUGH THE OMNIA PARTNERS PURCHASING COOPERATIVE FOR A TOTAL AMOUNT NOT TO EXCEED \$53,550.00**

**WHEREAS**, the City of Wheaton, Illinois, ("City") is an Illinois home rule municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and as such the City may exercise any power and perform any function pertaining to its government and affairs; and

**WHEREAS**, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, *et seq.*), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase supplies; and

**WHEREAS**, OMNIA Partners is a corporate organization located in Franklin, TN representing state and local governments, K-12 education, colleges, and universities worldwide and is authorized to contract with eligible entities to perform governmental functions including the purchase of goods and services; and

**WHEREAS**, the City is a member of the OMNIA Partners cooperative purchasing program, which establishes contracts for a variety of products and services through public and competitive solicitations, and permits member governments to purchase products and services through those contracts; and

**WHEREAS**, OMNIA Partners contract #R200601 has been publicly and competitively bid for Equipment and Tool Rental Services; and

**WHEREAS**, OMNIA Partners has identified Sunbelt Rentals, Inc. located in Aurora, Illinois, as the low responsible bidder for OMNIA Partners contract #R200601; and

**WHEREAS**, a total of \$290,000 is budgeted in the Storm Sewer Fund for equipment rental and storm sewer materials for the Thomas Road Drainage Improvement Project; and

**WHEREAS**, the corporate authorities of the City of Wheaton have determined that it is in the best interest of the City to procure the Rental of Two (2) 10-ton Dump Trucks for the Thomas Road Drainage Improvement Project from Sunbelt Rentals, Inc. located at 2605 Beverly Drive, Aurora, Illinois, 60502 in accordance with OMNIA Partners contract #R200601 for a total amount not to exceed \$53,550.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and the City Council of the City of Wheaton, Illinois, that:

The City's Purchase Order #2026047 for the Rental of Two (2) 10-ton Dump Trucks for the Thomas Road Drainage Improvement Project from Sunbelt Rentals, Inc. for a total amount not to exceed \$53,550, is hereby authorized (the "Purchase"). A copy of the City's Purchase Order #2026047 is on file with the City Clerk's office, and is incorporated herein as if fully set forth as Exhibit A.
