

RESOLUTION R-2025-47

**A RESOLUTION AUTHORIZING THE PURCHASE OF A MICROSOFT ENTERPRISE AGREEMENT
SUBSCRIPTION FOR A THREE-YEAR TERM FROM DELL MARKETING LP THROUGH THE STATE OF
ILLINOIS JOINT PURCHASE MASTER CONTRACT FOR A TOTAL AMOUNT NOT TO EXCEED \$35,049.24**

WHEREAS, the City of Wheaton, Illinois, ("City") is an Illinois home rule municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and as such the City may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, *et seq.*), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase supplies; and

WHEREAS, the State of Illinois has publicly and competitively bid for a Microsoft Enterprise Agreement Subscription; and

WHEREAS, the State of Illinois awarded Contract #25-448DOIT-INFOT-P-69783 to Dell Marketing LP, the lowest priced responsive and responsible bidder, for the provision of Microsoft products, support, and services and has made the contract available to other public entities; and

WHEREAS, a Microsoft Enterprise Agreement Subscription is offered under State of Illinois Contract #25-448DOIT-INFOT-P-69783 for an annual price of \$11,683.08 (\$35,049.24 total for three years); and

WHEREAS, the City budgeted \$23,800 in the Information Technology Department under the Software Licenses/Maintenance account in the General Fund; and

WHEREAS, the corporate authorities of the City of Wheaton find it is in the best interest of the City to purchase a Microsoft Enterprise Agreement Subscription from Dell Marketing LP, located at One Dell Way RR8-06, Round Rock, Texas 78582 through the State of Illinois joint purchase master contract #25-448DOIT-INFOT-P-69783 for a three-year term and for a total amount not to exceed \$35,049.24.

NOW THEREFORE, BE IT RESOLVED by the Mayor and the City Council of the City of Wheaton, Illinois, that:

Section 1. The foregoing recitals are incorporated into and made a part of this Resolution as findings of the Mayor and the City Council.

Section 2. The City's Purchase Order #2026069 for the purchase of a Microsoft Enterprise Agreement Subscription from Dell Marketing LP, located at One Dell Way RR8-06, Round Rock, Texas 78582, through the State of Illinois joint purchase master contract #25-448DOIT-INFOT-P-69783 for a three-year term and for a total amount not to exceed \$35,049.24, is hereby authorized (the "Purchase"). A copy of the City's Purchase Order #2026069 is on file with the City Clerk's office, and is incorporated herein as if fully set forth as Exhibit A.

Section 3. City staff is authorized and directed to undertake any and all other tasks necessary, or in the furtherance of, completion of the Purchase transaction.
