

**RESOLUTION R-2025-54**

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 546 FOR BULK ROCK SALT THROUGH THE DUPAGE COUNTY JOINT PURCHASING SOLICITATION WITH COMPASS MINERALS AMERICA, INC. TO BE PURCHASED ON AN AS NEEDED BASIS AT THE PRICE PER TON SET FORTH IN COMPASS MINERALS AMERICA, INC.'S COST PROPOSAL**

**WHEREAS**, the City of Wheaton, Illinois, ("City") is an Illinois home rule municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and as such the City may exercise any power and perform any function pertaining to its government and affairs; and

**WHEREAS**, pursuant to the Illinois Governmental Joint Purchasing Act (30 ILCS 525/1, *et seq.*), the City may purchase personal property, supplies, and services joining with other governmental units; and Illinois State Statutes authorize municipal governments to jointly purchase supplies; and

**WHEREAS**, the City participated in a joint purchasing solicitation (Bid #25-OSALT-02-MS) led by DuPage County, which included a total of 37 surrounding communities for Bulk Rock Salt; and

**WHEREAS**, DuPage County has publicly and competitively bid for Bulk Rock Salt and Compass Minerals America, Inc. was determined to be the lowest, responsive, responsible bidder; and

**WHEREAS**, it is determined that the bid from Compass Minerals America, Inc. for the purchase of Bulk Rock Salt meets the City's needs; and

**WHEREAS**, the City budgeted funds in the General Fund-Road Materials account in the amount of \$232,700 for Bulk Rock Salt; and

**WHEREAS**, the corporate authorities of the City of Wheaton find it reasonable and appropriate to enter into an agreement with Compass Minerals America, Inc. located at 9900 W. 109<sup>th</sup> Street, Overland Park, KS 66210 through the DuPage County joint purchasing solicitation Bid #25-OSALT-02-MS for the purchase of Bulk Rock Salt on an as needed basis at the price per ton set forth in Compass Minerals America, Inc.'s cost proposal.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 546 with Compass Minerals America, Inc. located at 9900 W. 109<sup>th</sup> Street, Overland Park, KS 66210 for the purchase of Bulk Rock Salt on an as needed basis at the price per ton set forth in Compass Minerals Americas Inc.'s cost proposal; and that a copy of that certain City of Wheaton Agreement No. 546 is on file with the City Clerk's office and is incorporated herein as if fully set forth as Exhibit A.
