

RESOLUTION R-2025-75
A RESOLUTION AUTHORIZING THE DISPOSAL
OF CERTAIN SURPLUS PROPERTY (PW)

WHEREAS, Section 2-506 of the Wheaton City Code sets forth a procedure for disposal of surplus property; and

WHEREAS, a request to dispose of property described in Exhibit "A" ["surplus property"] attached hereto and made a part hereof by reference, has been submitted; and

WHEREAS, the City Manager has determined that the surplus property is to be offered for sale or disposed of in an appropriate manner; and

WHEREAS, the City Manager has approved said request and forwarded it to the City Council for authorization.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois that the City Manager is authorized to proceed with sale or disposal of said surplus property in compliance with the provisions of Chapter 2, Article VII, Section 2-506 of the Wheaton City Code.
