

**RESOLUTION R-2025-92**

**A RESOLUTION AUTHORIZING THE EXECUTION OF AGREEMENT NO. 579 WITH  
COMCAST BUSINESS FOR ENTERPRISE NETWORK SERVICES AND INTERNET SERVICE FOR A THREE  
(3) YEAR TERM AND A TOTAL AMOUNT NOT TO EXCEED \$111,952.80 (\$37,317.60 ANNUALLY)**

**WHEREAS**, the City of Wheaton, Illinois, ("City") is an Illinois Home Rule Municipality pursuant to the provisions of Article VII, Section 6, of the Illinois Constitution of 1970; and as such the City may exercise any power and perform any function pertaining to its government and affairs; and

**WHEREAS**, the City had an existing agreement with Comcast Business for Enterprise Network Services and internet service that expired January 17, 2025; and

**WHEREAS**, Comcast Business submitted a proposal for the renewal of Enterprise Network Services and internet service for a three (3) year term and a total amount not to exceed \$111,952.80; and

**WHEREAS**, the City budgeted funds in CY2025 in multiple accounts for Enterprise Network Services and internet service in the amount of \$39,644; and

**WHEREAS**, both parties agree to the terms and conditions set forth in Agreement No. 579 for Enterprise Network Services and internet service; and

**WHEREAS**, the corporate authorities of the City of Wheaton, DuPage County, Illinois find it reasonable and appropriate to enter into an agreement with Comcast Business for Enterprise Network Services and internet service.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Wheaton, Illinois, that:

The Mayor is hereby authorized to execute, and the City Clerk is hereby directed to attest to City of Wheaton Agreement No. 579 with Comcast Business located at PO Box 37601 Philadelphia, Pennsylvania, 19101, for Enterprise Network Services and internet service for a three (3) year term and a total amount not to exceed \$111,952.80; and that a copy of that certain City of Wheaton Agreement No. 579 is on file with the City Clerk's office and is hereby incorporated herein as if fully set forth as Exhibit A.
