A RESOLUTION FOR THE IMPROVEMENT BY MUNICIPALITY UNDER THE ILLINOIS HIGHWAY CODE

BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois that the following described streets will be improved under the Illinois Highway Code:

1	Blanchard Circle	from	Naperville Road to Naperville Road
2	Carlton Avenue	from	Franklin Street to North Dead End
3	College Avenue	from	Washington Street to Blanchard Street
4	Crescent Street (East Phase)	from	President Street to Hill Street
5	Crescent Street (West Phase)	from	Washington Street to Chase Street
6	Daly Road	from	Milton Township Line to Glencoe Street
7	Franklin Street	from	Carlton Avenue to Ellis Avenue
8	Evergreen Street	from	President Street to Blanchard Street
9	Franklin Street	from	Ellis Avenue to West Street
10	Irving Avenue	from	Kenilworth Avenue to Harrison Avenue
11	Liberty Drive	from	Pierce Avenue to Knollwood Drive
12	Madison Avenue	from	Main Street to Irving Avenue
13	Prairie Avenue	from	Main Street to Santa Rosa Avenue
14	President Street	from	Crescent Street to Harrison Avenue
15	Wilmette Avenue	from	Madsen Court to Thomas Road

BE IT FURTHER RESOLVED:

1. That the proposed improvement consists of pavement rehabilitation to include a bituminous asphalt overlay with leveling binder and/or surface course; curb and gutter, drive approach and sidewalk removal and replacement; pavement milling; storm and sanitary main and structure replacement; water main replacement; water service replacement; area reflective crack control treatment; and landscaping; and be designated as Section 04-00096-00-FP.
2. That there is hereby appropriated the sum of Nine Hundred Ten Thousand Dollars and No Cents (\$910,000.00) for the improvement of said Section from the municipality's allotment of Motor Fuel Tax funds.
3. That said work shall be done by contract; and


BE IT FURTHER RESOLVED, that the Clerk is hereby directed to transmit two certified copies of this resolution to the district/regional office of the Department of transportation.
