

RESOLUTION R-20-05

**A RESOLUTION FOR THE IMPROVEMENT BY MUNICIPALITY
UNDER THE ILLINOIS HIGHWAY CODE**

BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, Illinois that the following described streets will be improved under the Illinois Highway Code:

1	Briarcliffe Boulevard	from	President Street to Brentwood Drive
2	Circle Avenue	from	Carlton Avenue to Carlton Avenue
3	Jefferson Street	from	Carlton Avenue to Ellis Avenue
4	Lincoln Avenue	from	495' East of Sherwin to Ellis Avenue
5	Lyon Avenue	from	Union Avenue to North Dead End
6	Madison Avenue	from	Carlton Avenue to Ellis Avenue
7	Main Street	from	Roosevelt Road to Seminary Street
8	Manchester Road	from	Gables Boulevard to County Farm Road
9	President Street	from	Harrison Street to Geneva Road
10	Union Avenue	from	Lyon Avenue to Western Avenue
11	Wesley Street	from	West Street to Main Street
12	Western Avenue	from	350' N. of Wesley St. to Lincoln Avenue

1	Carrol Gate	from	Hevern Drive to Stuarton Drive
2	Hamilton Court	from	High Knob Drive to End
3	Hamilton Drive	from	Hamilton Drive to Stuarton Drive
4	Hamilton Lane	from	High Knob Drive to Hamilton Drive
5	Hevern Drive	from	Carol Gate East and West to ends
6	High Knob Drive	from	Orchard Road to Carol Gate
7	Stuarton Drive	from	Hamilton Drive to End

Water Main Replacement:

Wheaton Oaks Court from Prairie Avenue to end

BE IT FURTHER RESOLVED:


1. That the proposed improvement consists of pavement rehabilitation and reconstruction to include aggregate base removal and replacement, a bituminous asphalt overlay with leveling binder and/or surface course; curb and gutter, drive approach and sidewalk removal and replacement; pavement milling; storm and sanitary main and structure replacement; water main replacement; water service replacement; area reflective crack control treatment; and landscaping; and be designated as Section 05-00097-00-FP.

2. That there is hereby appropriated the sum of One Million, Nine Hundred Forty-Seven Thousand, Five Hundred Fifty Dollars, and No Cents (\$1,947,550) for the improvement of said Section from the municipality's allotment of Motor Fuel Tax funds.

3. That said work shall be done by contract; and


BE IT FURTHER RESOLVED, that the Clerk is hereby directed to transmit two certified copies of this resolution to the district/regional office of the Department of transportation.
