

**RESOLUTION R-46-05**

**A RESOLUTION AUTHORIZING THE ISSUANCE OF SOLID WASTE  
COLLECTION AND DISPOSAL LICENSES**

**WHEREAS**, Chapter 54 of the Wheaton City Code requires the City Council to authorize the issuance of Solid Waste Collection and Disposal Licenses; and

**WHEREAS**, the City has received Solid Waste Collection and Disposal License applications for commercial, office, industrial or institutional collection from Arc Disposal & Recycling Co., Inc., Flood Brothers Disposal & Recycling and K. Hoving Recycling & Disposal, Inc.; and

**WHEREAS**, the City has received Solid Waste Collection and Disposal License applications for multifamily and commercial, office, industrial or institutional collection from Waste Management of Illinois, Inc., Molenhouse Enterprises, Inc., Allied (B.F.I). Waste Services, Onyx Waste Services Midwest, Inc., and Crown Recycling & Waste Services, Inc.; and

**WHEREAS**, each applicant has reviewed and agreed to all requirements of the Solid Waste Collection and Disposal Licenses; and

**WHEREAS**, the City Council desires to issue Solid Waste Collection and Disposal Licenses to Arc Disposal & Recycling Co., Inc., Flood Brothers Disposal & Recycling and K. Hoving Recycling & Disposal, Inc to provide service to non-residential properties; and to Waste Management of Illinois, Inc., Molenhouse Enterprises, Inc., Allied (B.F.I). Waste Services, Onyx Waste Services Midwest, Inc., and Crown Recycling & Waste Services, Inc. to provide service to non-residential properties and multifamily residential properties that have a centralized garbage dumpster system.



Waste Services Midwest, Inc., and Crown Recycling & Waste Services, Inc., for a period ending June 30, 2006.
