A RESOLUTION APPROVING THE FINAL PLAT  
FOR PALERMO'S PLAT OF RESUBDIVISION  
(1320 Avalon Court)


WHEREAS, the Final Plat of Subdivision for Palermo's Plat of Resubdivision has been submitted to and reviewed by the Wheaton City staff (the property is described on Exhibit "A" attached to this resolution); and the Wheaton City staff has recommended that the Final Plat of Subdivision be approved with the following restrictions, conditions, and requirements.

1. The owners shall remove all physical improvements, except for landscaping improvements, from proposed Lot 2, including the gazebo, the concrete walk between the gazebo and pool patio, and the iron fencing prior to recordation of the plat.


NOW, THEREFORE, be it resolved by the Mayor and City Council of the City of Wheaton, Illinois that the Final Plat of Subdivision for Palermo's Plat of Resubdivision prepared by Allen D. Carradus, an Illinois professional land surveyor, dated May 4, 2005 is hereby approved.

IT IS FURTHER RESOLVED that the Mayor is authorized to sign the approval form and the City Clerk is authorized and directed to attest to the signature of the Mayor and attach a certified copy of the resolution to the Final Plat of Subdivision for Palermo's Plat of Resubdivision, prepared by Allen D. Carradus, an Illinois professional land surveyor, dated May 4, 2005.
