
A RESOLUTION APPROVING THE FINAL PLAT OF SUBDIVISION



Windham Commons Subdivision

Legal Description:

THAT PART OF THE NORTHEAST QUARTER OF SECTION 8, TOWNSHIP 39 NORTH, RANGE 10 EAST OF THE THIRD PRINCIPAL MERIDIAN, DESCRIBED BY COMMENCING AT THE NORTHEAST CORNER OF SAID NORTHEAST QUARTER AND RUNNING THENCE WESTERLY, 678.0 FEET ALONG THE NORTH LINE OF SAID NORTHEAST QUARTER; THENCE SOUTH 00 DEGREES 03 MINUTES 42 SECONDS EAST, 192.0 FEET PARALLEL WITH THE EAST LINE OF SAID NORTHEAST QUARTER FOR A POINT OF BEGINNING; THENCE CONTINUING SOUTHERLY ALONG THE PREVIOUSLY DESCRIBED COURSE, 740.99 FEET PARALLEL WITH SAID EAST LINE; THENCE SOUTH 89 DEGREES 03 MINUTES 48 SECONDS WEST, 326.02 FEET PARALLEL WITH SAID NORTH LINE (BEING ALONG THE NORTH LINE OF ASHBURY COURT SUBDIVISION); THENCE NORTH 00 DEGREES 03 MINUTES 42 SECONDS WEST, 731.99 FEET PARALLEL WITH SAID EAST LINE; THENCE NORTH 89 DEGREES 03 MINUTES 48 SECONDS EAST, 150.02 FEET PARALLEL WITH SAID NORTH LINE; THENCE NORTH 00 DEGREES 03 MINUTES 42 SECONDS WEST, 9.00 FEET PARALLEL WITH SAID EAST LINE; THENCE NORTH 89 DEGREES 03 MINUTES 48 SECONDS EAST, 176.00 FEET PARALLEL WITH SAID NORTH LINE TO THE POINT OF BEGINNING, IN DUPAGE COUNTY, ILLINOIS.
