

RESOLUTION R-98-05

A RESOLUTION AUTHORIZING THE DESTRUCTION OF AUDIO OR
VIDEO RECORDING OF CLOSED SESSION MEETINGS AND APPROVAL OF CLOSED
SESSION MEETING MINUTES

WHEREAS, the Open Meetings Act requires governmental bodies to audio or video record their closed meetings; and

WHEREAS, this governmental body has complied with that requirement; and

WHEREAS, the Open Meetings Act permits governmental bodies to destroy the verbatim record of closed meetings without notification to or the approval of a Records Commission or the State Archivist not less than eighteen (18) months after the completion of the meeting recorded, but only after:

1. It approves the destruction of a particular recording; and
2. Approves written minutes of the closed meeting; and

WHEREAS, for the verbatim record by tape of the meetings set forth in Section 1 of this Resolution, at least eighteen (18) months have passed since the completion of those meetings, and this governmental body is, through this resolution, also approving written minutes for each of the meetings or portions of meetings set forth in Section 1 as well as any other closed session minutes as listed on attachment "A" to this resolution; and

WHEREAS, this governmental body may order the destruction of the verbatim record even if it continues to withhold the approved written minutes of the closed session until some later period of time.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Wheaton, DuPage County, Illinois, as follows:

Section 1: Based upon the statements made within the preamble to this resolution, the Mayor and City Council of the City of Wheaton hereby orders the destruction of the verbatim record being an audio or video tape of the following full meetings or portions of meetings:

Wheaton City Council Closed Sessions: February 17, 2004 (all); May 17, 2004 (all); and May 24, 2004 (all).

Section 2: This resolution shall be in full force and effect immediately upon its passage.
