**Answer:** Engineering design services are within the current budget. Details will be provided upon review of submittals. Final budget amounts for construction engineering and construction are not complete and contingent on the engineering design.

**Answer:** Engineering design to be completed prior to 4/30/16. Construction for Countryside Generator scheduled for May 2016 to April 2017. Construction for President Generator scheduled for May 2017 to April 2018.
