

ORDINANCE NO. F-1088

**AN ORDINANCE AMENDING THE OFFICIAL MOTOR
VEHICLE AND TRAFFIC SCHEDULES (CHAPTER 70)
FOR THE CITY OF WHEATON, ILLINOIS
(NO PARKING)**


BE IT ORDAINED by the Mayor and City Council of the City of Wheaton, Illinois, as follows:

SECTION 1: That the Official Motor Vehicle and Traffic Schedule VI. (Parking prohibited at all times on certain streets) as referred in Section 70-354(c) of the Wheaton City Code, 1996, as amended, is hereby amended to read as follows:


- (93) Brighton Drive – south side – from Orchard Road to Hampton Drive.
- (94) Dorset Drive – east side/north side – from Gladstone Drive to Brighton Drive.
- (95) Colonial Square – south side from Orchard Road to Berkshire Place.
- (96) Berkshire Place – east side from Sherwood Place to Brighton Drive.
- (97) Sherwood Place – west side – from Brighton Drive to Dorset Drive.
- (98) Richton Drive – west side – Brighton Drive to Dorset Drive.
- (99) Buckingham Court – north side – from Greensboro Drive to include the cul-de-sac.
- (100) Burnham Place – west side – from Buckingham Drive to Dorset Drive.
- (101) Greensboro Drive – east side – from Dorset Drive to Brighton Drive.
- (102) Somerset Lane – east side/north side – from Brighton Drive to Gladstone Drive.
- (103) Buckingham Drive – south side – from Sherwood Place to Greensboro Drive.
East side – from Somerset Lane to Brighton Drive.
- (104) Canterbury Place – west side – from Dorset Drive to Cromwell Drive.
- (105) Cromwell Drive – west side – from Butterfield Road to Brighton Drive.
- (106) Gladstone Drive – east side – from Brighton Drive to Chatham Drive.
- (107) Middleton Drive – east side – from Somerset Lane to Chatham Drive.
- (108) Bedford Court – east side – from Somerset Lane to include the cul-de-sac.
- (109) Middleton Court – east side – from Middleton Drive to include the cul-de-sac.

SECTION 2: That all ordinances or parts of ordinances in conflict with provisions of this ordinance are hereby repealed.

SECTION 3: That this ordinance shall become effective from and after its passage, approval and publication in a manner provided by law.
